Accurint® for Government - Basic

Accurint® for Government – Business

In this session, participants will review Business Searches to explore, in part: verification that a business exists - corporate filings, Tax Identification Number, FEIN, etc. Businesses in the News (M&A, negative news, financial reporting, etc.) Understand the derogatory profile of a business (bankruptcies, judgements) business contacts (registered agents, managers, C-level executives, etc.).



Accurint® for Government – Asset Finding
